The Meadows Neighborhood Company (MNC) Pool Rules

POOL MANAGEMENT COMPANY – Front Range Recreation (FRR)

HOURS

- General swim hours are 10am – 8pm beginning Memorial Day weekend. Once school begins, pool hours may be reduced. Pool hours will be posted on the MNC website and at the pool.

HYGIENE & ATTIRE

- Please shower before swimming. Restrooms are in the pool house.
- Approved swimwear required. No gym shorts, cut-offs, thongs, leotards, transparent fabric, or other “non-swimwear” gear.
- No disposable diapers. Only cloth diapers covered by rubber pants or “swimmer” pull-ups are allowed.
- Only Coast Guard-approved flotation devices are permitted. Flotation devices not permitted include those blown or pumped up (ex. water wings), or swimsuits with built-in flotation rings/devices incapable of self-correction.
- People with open sores, skin infections, contagious diseases, or bandages may not be allowed in the water.

SAFETY

1. Swimming is only allowed during posted pool hours. Lifeguards must be present during any swimming activity.
2. 15-minute safety breaks will be taken every two (2) hours at 12pm, 2pm, 4pm, and 6pm. Only lap swimming will be permitted during safety breaks.
3. Pools may be closed due to inclement weather, lightning, repairs, maintenance issues and other occurrences.
4. Safety breaks, inclement weather, and closings are at the discretion of FRR.

WEATHER POLICY

- FRR reserves the right to close the pool during inclement weather at the discretion of the lifeguards on duty.
- Weather will be monitored through a reputable weather app determined by FRR.
- The pool area will be cleared when the below is occurring:
 - Conditions warranting closure include lightning, thunder (even if no lightning has been seen), extreme wind, rain, threatening clouds, tornado warnings and/or the temperature drops below 65 degrees.
 - In the case of lightning within an 8-mile radius, the pool will close for 30 minutes from the last lightning strike. Every subsequent strike within an 8-mile radius will restart the 30-minute clock. The pool will reopen when the lifeguards on duty deem it safe.
 - On days when weather does not meet the minimum air temperature, FRR will keep one lifeguard at the pool. If the weather is unsuitable for swimming at 6pm or the forecast will prevent the opening of the pool, then the pool will be closed for the day.

THE GRANGE WATER SLIDE

1. All persons under 46 inches must be able to successfully swim 15 yards, to the satisfaction of MNC lifeguards, without flotation aid, to use the waterslide.
2. Sliders will be asked to enter the water prior to entering the slide line.
3. Sliders must sit with their feet forward on backside. No twisting, turning, flipping, kneeling, standing, or stopping.
4. Only one slider allowed on the slide at a time. Please exit splashdown area immediately after each ride.
5. Goggles, hats, shirts, flotation devices, and jewelry are prohibited.
6. Medically required eyeglasses must be securely affixed with head straps.
7. Sliders must always obey the slide attendant.

SUPERVISION OF CHILDREN

1. Supervision required for anyone unable to swim 15 yards independently regardless of age, and for children 0-10.

2. Persons must be at least 11 years of age or older and able to swim 15 yards independently to visit the pool without supervision by a “responsible and reliable person.”
3. A person is a “responsible and reliable person” if they are 16 or older and assume full and complete responsibility for the safety of persons who require supervision under his or her responsibility. A “responsible and reliable person” must always accompany and remain with the supervised individual.
4. Caregivers (babysitter, nanny, au pair) must be 16+ to supervise MNC residents under the age of 11 while such persons are in the swimming pool area.
 - a. **DISCLAIMER:** *If a child is hurt during the supervision of the Caregiver, MNC does not assume or accept responsibility. Parents/guardians are responsible for the Caregivers and should thoroughly review all pool policies when completing the MNC Caregiver Fob Application.*
5. Children over 7 years of age may not use the restroom or changing room facility of the opposite sex.

BEHAVIOR

1. To ensure the safety of all Members, unsafe or inappropriate behavior and/or violation of facility rules will result in the offending party directed to leave the facility immediately. In addition, individuals who engage in unacceptable, unsafe, or irresponsible behavior may have their access to facilities suspended or revoked and are subject to any other discipline provided for in the MNC Declaration.
2. Cameras, tablets, or any photo-taking device may not be used in changing rooms and/or restrooms.
3. No running, rough play, biking, skateboarding, roller blading, throwing hard objects, or similar activity is allowed.
4. No smoking is allowed, including tobacco, e-cigarettes, marijuana, or vaping products.
5. Consumption of alcoholic beverages or illicit drugs are prohibited at the pools.
6. MNC staff and/or lifeguards reserve the right to enforce rules as to actions and/or behaviors that are upsetting or at personal risk to staff or guests.

GUEST ACCESS

- Only MNC Residents and their guests are permitted to use pool facilities.
- Residents may bring up to 4 guests per day for \$5 per person (ages 3+). Pay via cash, card, or check.
- MNC reserves the right to change, without notice, the number of guests permitted based on capacity.

FOOD AND BEVERAGE

1. Food and drinks will be allowed in designated areas only.
2. There are vending machines on the pool deck that accept cash, card, and Apple Pay.
3. Personal food may be brought into the pool facilities, but cannot be within 5 ft. of the pool.
4. Glass bottles and glass containers are not allowed in the pool area.
5. Possession and consumption of alcoholic beverages on MNC property is strictly prohibited and is cause for removal, except during MNC-approved functions.

POOL ACCESS WILL BE REVOKED IF

1. Homeowners must be current in payment of Association assessments.
2. Failure to comply with any policies or procedures of The MNC.
3. Misuse of pool facility and/or equipment.
4. Harassment of other users, FRR personnel, and/or MNC management.
5. Obstructing lifeguarding personnel from completing job requirements.
6. Any instructor giving lessons who is not employed/contracted by FRR will be asked to leave the premises.
7. No animals will be allowed on the pool deck unless permitted by law.
