Pinery West Metropolitan District No. 2 (Pradera) POOL RULES

- 1) Pool hours the pool is open for use between the hours of 10:00 a.m. 8:00 p.m. daily (all times are subject to change).
- 2) Children twelve (12) years of age or younger must be supervised at all times by an adult, age eighteen (18) or older. Children thirteen (13) through seventeen (17) must demonstrate an ability to swim (to be at the lifeguard's discretion) or must be supervised at all times by an adult, age eighteen (18) or older.
- 3) Each pool user may have a maximum of three (3) guests and guests are not allowed to use the pool unless the Pradera resident, or, non-Pradera resident member is present at the pool at all times.
- 4) Swim diapers must be used if children wearing diapers are utilizing the pool or "baby pool" area.
- 5) Persons having infectious diseases, open sores, cuts or recent vaccinations are not permitted in the pool area.
- 6) No alcoholic beverages are allowed in the pool area.
- 7) Food and candy are restricted to perimeter areas. GLASS CONTAINERS AND GLASS OBJECTS OF ANY KIND ARE NOT PERMITTED IN THE POOL AREA AT ANY TIME.
- 8) No tobacco products are allowed on the pool grounds.
- 9) Trash shall be disposed of in appropriate containers.
- 10) Bicycles, trikes, skateboards, roller skates, or other play similar equipment are not allowed in the swimming pool area.
- 11) Pets are not allowed in the swimming pool area. Pets may not be tied to the fence surrounding pool.
- 12) HORSEPLAY, RUNNING, SPITTING, UNDUE SPLASHING, AND EXCESSIVE NOISE ARE NOT ALLOWED. Swimmers are not to play or hang on swim lane ropes.
- 13) Pool toys and rafts are allowed at the lifeguard's discretion.
- 14) Loud radios, CD or MP3 players are not allowed.
- 15) Adults have priority for pool furniture use.
- 16) All swimmers must wear swimming attire no cut-offs or shorts allowed. Pool members and guests must also have swimming attire on in the pool area unless it is an adult, age 18 or older, supervising a child in the pool.
- 17) Pradera residents and non-Pradera resident members must be current in the payment of annual assessments before they will be permitted to register and use the pool.
- 18) The lifeguards have total authority in regard to control of person using the pool. In the case of large groups, the lifeguards reserve the right to enforce a ratio of one (1) adult to seven (7) children if inappropriate behavior is displayed. They also have the right and obligation to close the pool whenever the conditions or weather presents a hazard.

ANYONE WHO VIOLATES THESE RULES MAY HAVE POOL PRIVILEGES SUSPENDED FOR WHATEVER PERIOD IS DEEMED APPROPRIATE BY THE LIFEGUARD, DISTRICT MANAGER OR PINERY WEST METROPOLITAN DISTRICT NO. 2 (PRADERA).
